

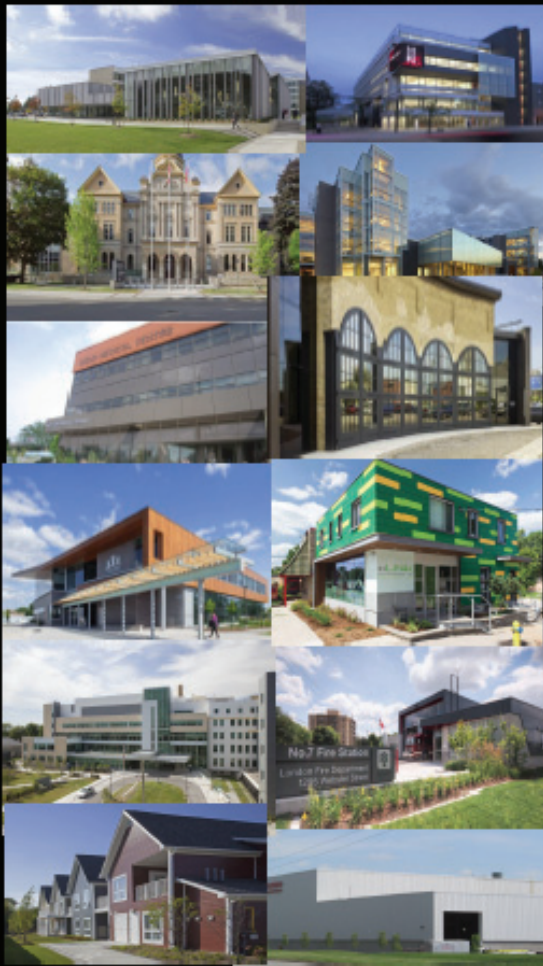

Eligibility

Investment, commercial or industrial building, development or renovation projects located within the jurisdiction (Elgin and Middlesex Counties) of the London and St. Thomas Association of REALTORS® (LSTAR).

Categories

- Commercial (including retail and office buildings);
- Industrial;
- Multi-family; and
- Institutional (Community)

Judges may develop sub-categories based on nominations received.

A panel of five local judges will visit each nomination individually, look at the overall exterior design of the project and determine how it fits into the surrounding area. Once all sites have been visited, the judges will decide on the winners. The prestigious panel of judges for 2017 includes:

- Design and innovation
- Answers a specific developmental need in the community
- Completed between August 1, 2015 and July 31, 2017.
