Investment, commercial or industrial building, development or renovation projects located within the jurisdiction (Elgin and Middlesex Counties) of the London and St. Thomas Association of REALTORS® (LSTAR).

#### Categories

- Commercial (including retail and office buildings)
- Green
- Industrial
- Multi-Family
- Institutional (Community)

Judges may develop sub-categories based on nominations received.

A panel of four local judges will review each nomination individually, look at the overall exterior design of the project and determine how it fits into the surrounding area. Once all sites have been reviewed, the judges will decide on the winners.

- Answers a specific developmental need in the community
- Completed between August 1, 2023 and July 31, 2025
