Market Holds Steady

455 homes exchanged hands in the first month of 2016, this represented only - 0.8% less for Detached and down -17.9% for Condo's for a total of -4.2% over the previous January. "You have to keep in mind that last January was the 2nd best January Sales since 2007 so this month's stat's shows our market is steady" says Stacey Evoy, 2016 President of the London and St. Thomas Association of REALTORS®.

1,053 properties were listed in January, down 11.6%, and Active Listings End of Period – or inventory – was also down 16.0%. "Our market continues to be balanced," says Evoy. "However, if you're thinking of selling, it might be an idea to list ahead of the spring rush."

January was a slow month for real estate in St. Thomas, with sales totaling 23. The average price of a home in St. Thomas so far in 2016 stands at \$197,792 down 5.7%.

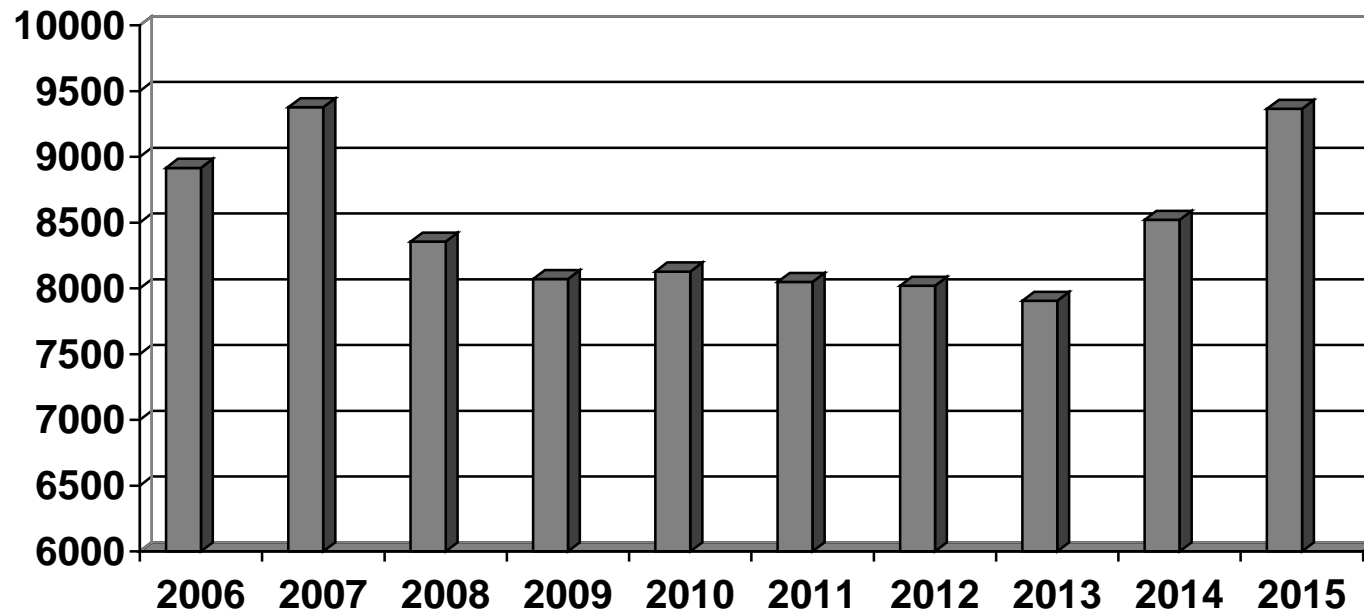

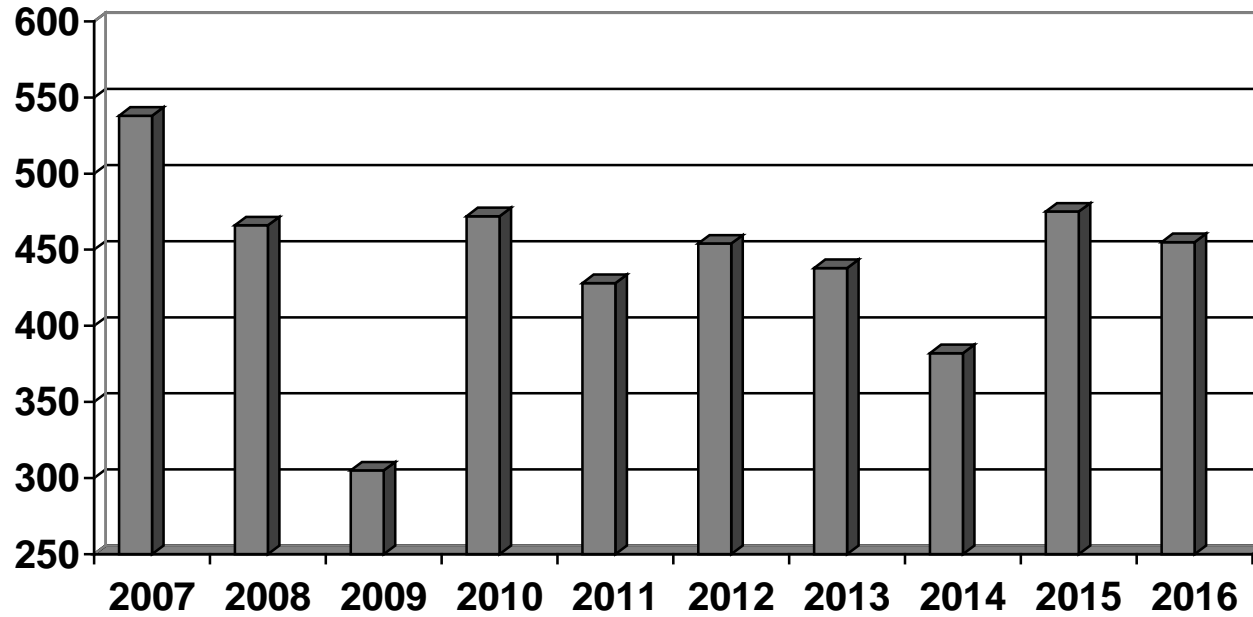

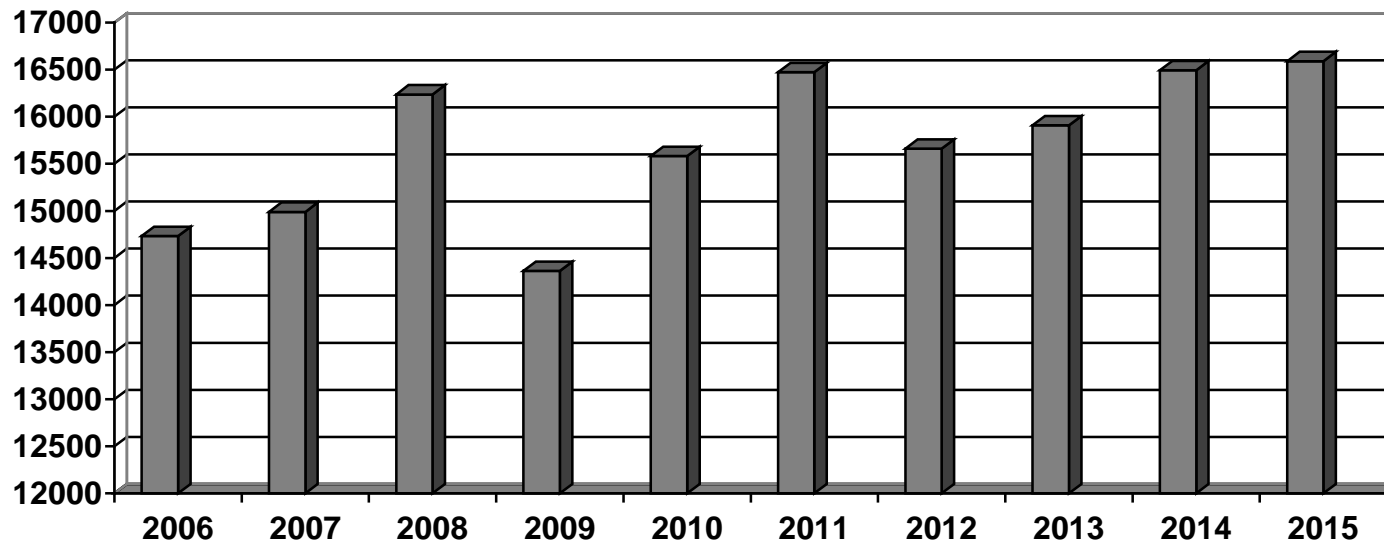

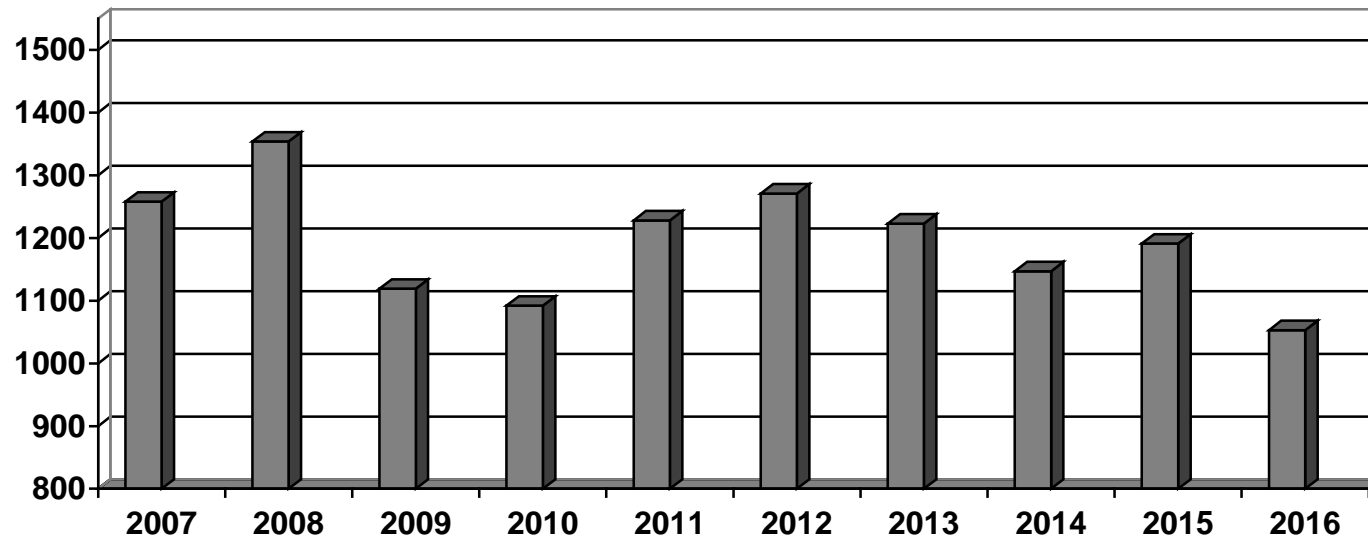

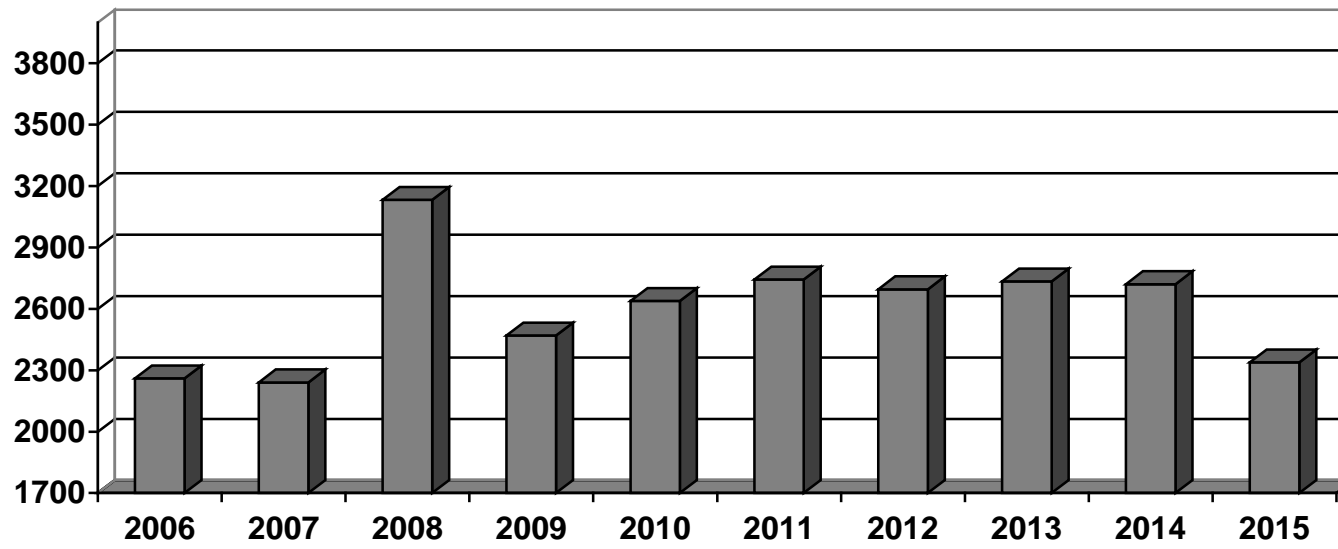

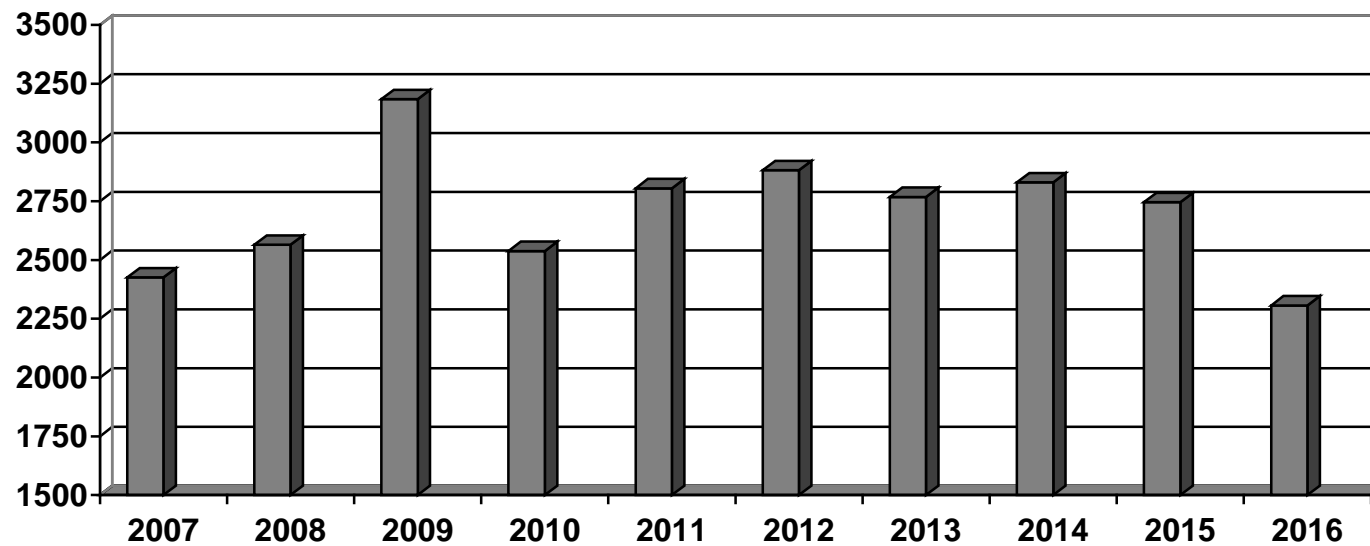

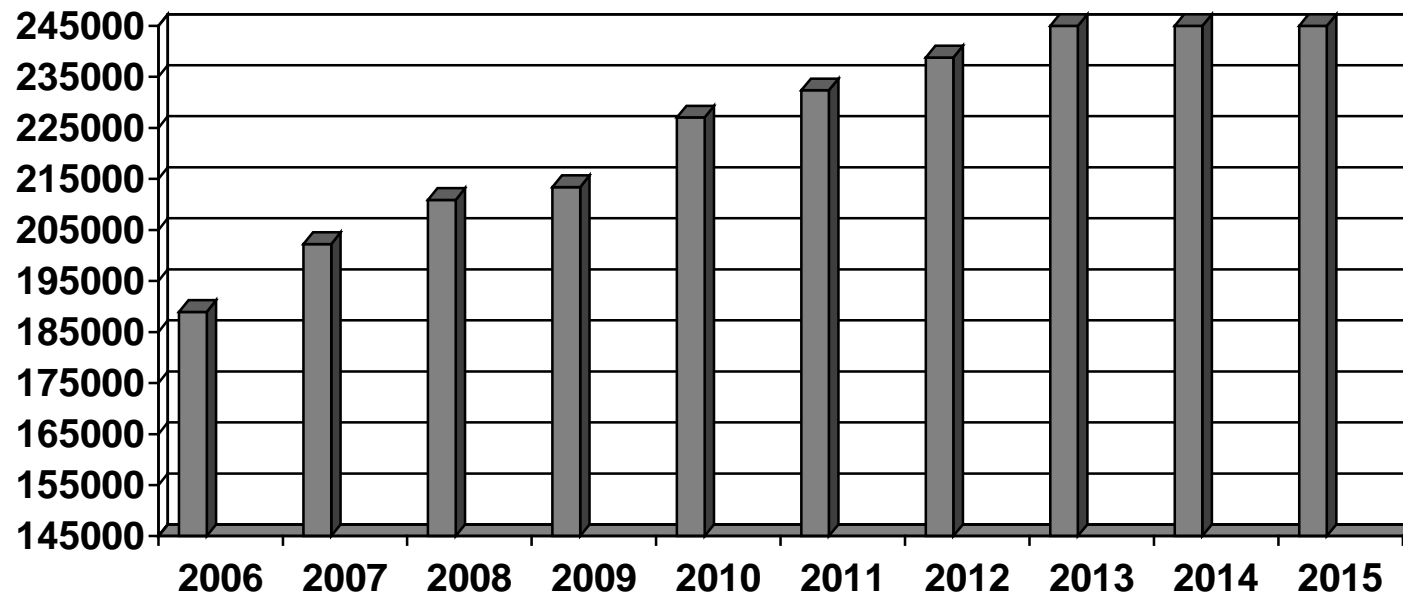

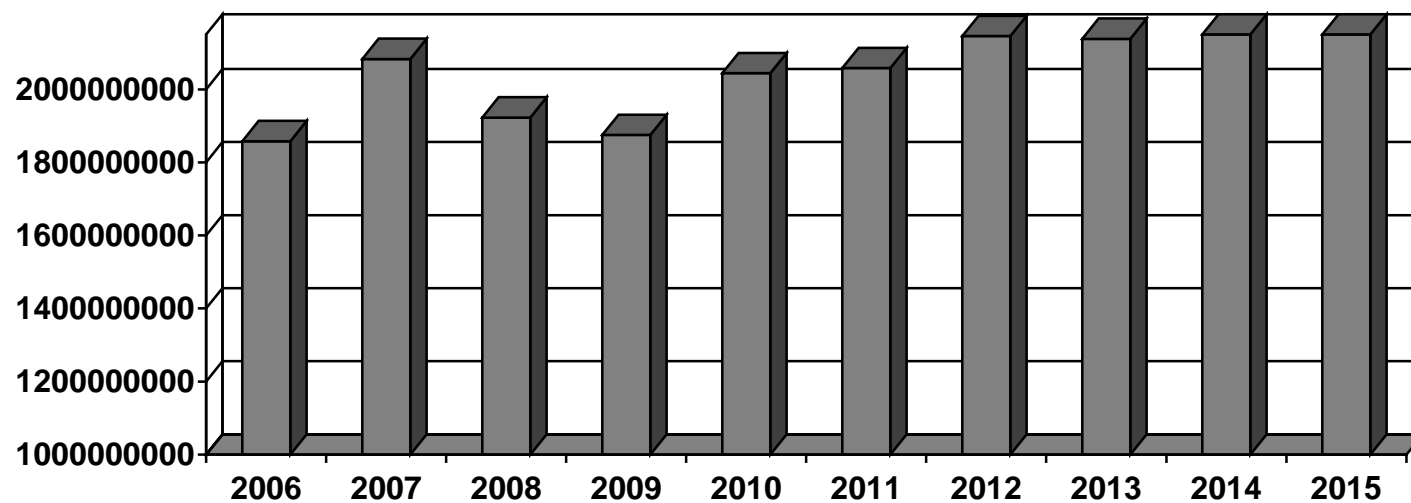
Average Residential Price in Association's Jurisdiction (10 year review)

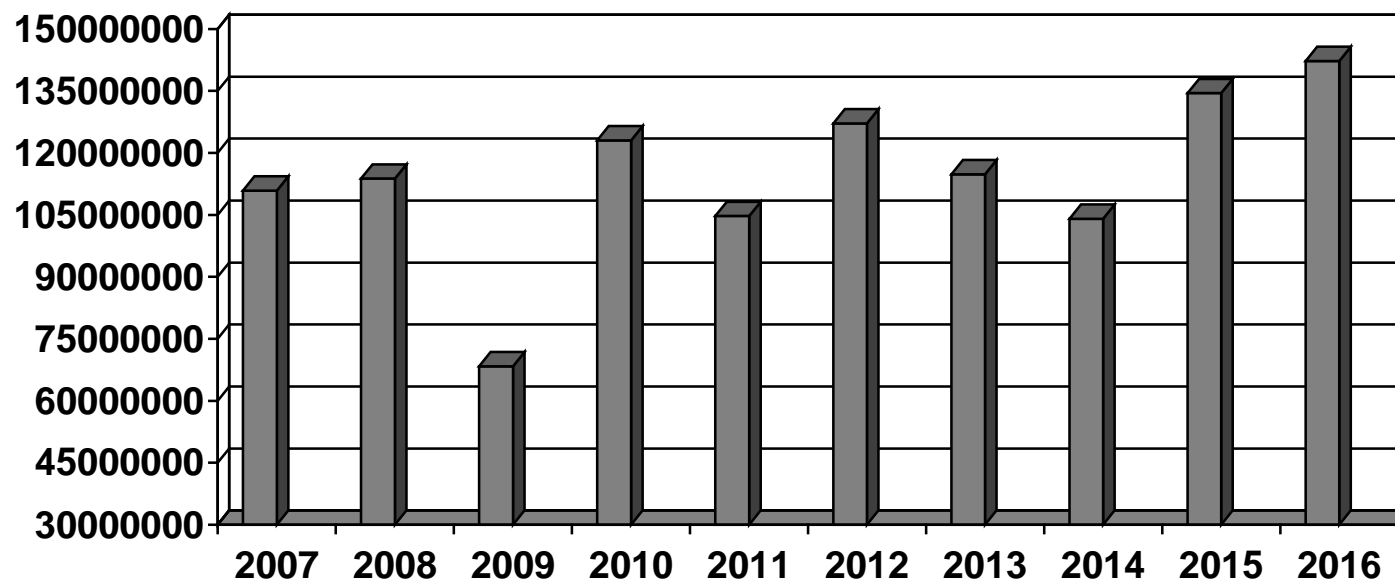
